New business: None.

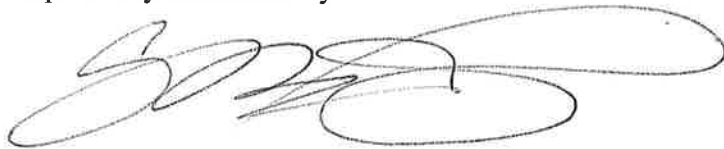
Public Comments: Speakers are each allotted three minutes. Motion to add additional speaker #5, by Member Hand, second by Member Glade; motion carries 5-0.
