**A RESOLUTION OF THE CHEROKEE COUNTY BOARD OF COMMISSIONERS TO FIX, SET, AND PUBLISH A QUALIFYING FEE FOR EACH COUNTY OFFICE TO BE FILLED IN THE 2024 PRIMARY OR GENERAL ELECTION IN ACCORDANCE WITH THE PROVISIONS OF O.C.G.A. § 21-2-131; AND FOR OTHER PURPOSES.**

**WHEREAS**, the Board of Elections and Registration of Cherokee County has requested that the Cherokee County Board of Commissioners set qualifying fees for various County offices within Cherokee County to be filled via primary or election in 2024; and

**WHEREAS**, O.C.G.A. § 21-2-131 states that qualification fees for each county office shall be fixed and published by the governing authority of the county no later than February 1 of the year in which a general primary, nonpartisan election, or general election is to be held; and

**WHEREAS**, except as otherwise provided in O.C.G.A. § 21-2-131, such fee shall be three percent (3%) of the total gross salary of the office paid in the preceding calendar year including all supplements authorized by law if a salaried office; and

**WHEREAS**, the Board of Commissioners desires to comply with said request from the Board of Elections and Registration and hereby wishes to set and direct the publishing of the qualifying fees for the County offices to be filled via primary or election in 2024; and

**NOW, THEREFORE, BE IT RESOLVED** by the Cherokee County Board of Commissioners, and it is hereby so resolved by the authority of the same, that the Board of Commissioners does hereby fix and set a qualifying fee as set forth in O.C.G.A. § 21-2-131 for the County offices to be filled in the upcoming 2024 primary or election as follows:
