Call to Order: Chair – Glen Johnson - 9:34 AM.

Members Present: Chair - Glen Johnson, Vice Chair - Julie Glade, Secretary - Larry Hand, John Wallace.

Approval of Monthly Board Meeting Agenda: Member Glade made a motion to approve the agenda; Second by Member Wallace. Motion carries 4-0.

Approval of Previous Meeting Minutes:

Regular Monthly Board Meeting – Monday, March 2, 2026.

Member Wallace made a motion to approve the minutes of the March 2, 2026, meeting; Second by Member Hand. Motion carries 4-0.

Director's Report: Director Dover advised that early voting would begin April 27 for the May 19, 2026, General Primary. She advised that Voter Roll maintenance was progressing well and that several voter information classes had been conducted or were scheduled. She also advised that she had checked the voter rolls concerning the possible additional voters registered at the address of one of the public speakers at the March BOE meeting and there were no additional voters currently shown on the voter rolls at that address. The recent GAVREO conference was also discussed. In addition, there were discussions concerning the uncertainty of the voting processes after July 1, 2026, because of the lack of legislative actions in 2025 and 2026.

Unfinished/Old Business: None

New Business:

Polling Location Change – Woodstock Precinct Voters move from The Woodlands Clubhouse to Little River Elementary School. Member Wallace made a motion to move the precinct voting location from The Woodlands Clubhouse to Little River Elementary School, at least, until after the 2028 Presidential election; Second by Member Glade.

Member Hand requested an amendment to the motion to remove “, at least, until after the 2028 Presidential election” from the motion; Second by Member Glade. Motion carries 4-0.

Sunday Voting – Sunday, May 3, 2026, from 1:00 PM – 5:00 PM, could be added as an additional Early Voting Day for the June 7, 2026, General Primary. Member Glade made a motion to conduct early voting on Sunday, May 3, 2026, from 1:00 PM – 5:00 PM; Second by Member Wallace. Motion carries 4-0.
