Approval of Monthly Board Meeting Agenda: Member Hand made a motion to approve the agenda; Second by Member Glade. Motion carries 4-0.

Approval of Previous Meeting Minutes:

-Regular Monthly Board Meeting – Monday, May 4, 2026.

Member Wallace made a motion to approve the minutes of the May 4, 2026, meeting; Second by Member Glade. Motion carries 4 -0.

-Special Called Board Meeting to Review Returns for the May 19, 2026, Closed Primary – Friday, May 22, 2026, at 3 PM.

Member Glade made a motion to approve the minutes of the May 22, 2026, 3 PM meeting; Second by Member Wallace. Motion carries 4-0.

-Special Called Board Meeting to Certify the May 19, 2026, Closed Primary – Friday, May 22, 2026, at 5 PM.

Member Hand made a motion to approve the minutes of the May 22, 2026, 5 PM meeting; Second by Member Glade. Motion carries 4-0.

Director's Report: Director Dover discussed the schedule for the upcoming June 16, 2026, Runoff, her attendance at the upcoming SEB meeting, two referrals for possible election day violations, and the preparation for the July 1, 2026, swearing in of the new Board member to replace Member Hand. She also advised that the elections office staff had received a second National award for their voter outreach efforts. Additionally, she advised that the RLA for the Closed Primary with the hand counting of 8,000+ ballots was conducted and there were no errors found in the results.

Unfinished/Old Business: Previous matter of the Board review of any referral to the Secretary of State of alleged violations of the election code:

After further discussion, Member Glade made the following motion:

“Motion on Board procedure regarding referral to the Secretary of State of alleged violations of the election code, specifically, that once informed by Director Dover of a potential violation, the Board has discretion to discuss the matter at a public meeting, or discuss the matter via email, with the goal of providing Director Dover with feedback on the board's position on the matter. The Board should take care to avoid mentioning the alleged violator's names whether in public meetings or emails.”

Member Glade's motion regarding referral to the Secretary of State of alleged violations of the election code was Seconded by Member Wallace. Motion carries 4-0.

Member Wallace made a motion to move the Victoria Precinct polling location (election day only) from Rose Creek Public Library to Bascomb Elementary School; Second by Member Hand. Motion carries 4-0.

Move Hillside Precinct polling location (election day only) from Hillside Church to Rose Creek Public Library, 4476 Towne Lake Parkway, Woodstock, GA 30189.

Member Wallace made a motion to move the Hillside Precinct polling location (election day only) from Hillside Church to Rose Creek Public Library; Second by Member Hand. Motion carries 4-0.
